### 3. Purpose of data processing

The purpose of the processing is the organisation of the talk. An additional purpose of the processing is the collection of aggregate participant statistics.

The talk will serve as part of DKRZ's documentation and will therefore be recorded and published via the DKRZ web page, its youtube feed or similar means. Participants who do not wish to appear in the recording, must leave their camera switched off and their microphone muted. The questions and answers will be collected in a editable document (hedgedoc) hosted by GWDG<sup>1</sup>selected questions will be read to the speakers and a summary will be provided in an online document as part of DKRZ's documentation. Participants who do not want questions to be published are free to contact the presenters after the talk via standard means of communication.

### 4. Legal basis of data processing

The legal basis of data processing for event organization is the contract that is concluded with us upon registration (Art. 6 Abs. 1 lit. b GDPR).

If you have consented to this, the legal basis for the collection of participant statistics is precisely this consent (Art. 6 Abs. 1 lit. a GDPR).

The legal basis for processing in these instances is Article 6, para. 1, lit. f GDPR (legitimate interests of the controller).

### 5. Recipients and categories of recipients

The registration data are collected and used within DKRZ for the sole purpose of organizing and realizing the talk, which will be held as a virtual event.

Your name and e-mail address are required for registration. The workshop will be held using the video conference software zoom<sup>2</sup> by DKRZ. The slides of the presentations will be made publicly available on the DKRZ website <https://indico.dkrz.de>. During talk, questions from the audience will be collected in an editable document (hedgedoc) hosted by GWDG, which will be accessible via a public URL. After the event, aggregate data without personal reference may be used for documentation, dissemination and communication purposes. A passing on of data to third parties does not take place.

### 6. Storage duration
