

Information on data processing in conformity with Art. 13 General Data Protection Regulation

3. Purpose of data processing

The purpose of the processing is the organisation of the seminar. An additional purpose of the processing is the collection of aggregate participant statistics.

The seminar will not be recorded. Questions and answers will be collected in an editable document (hedgedoc) hosted by GWDG¹. Selected questions will be read by the speakers and a summary will be provided in an online document as part of DKRZ's documentation. Participants who do not want questions to be published are free to contact the presenters after the talk via standard means of communication.

4. Legal basis of data processing

The legal basis of data processing for event organization is the contract that is concluded with us upon registration (Art. 6 Abs. 1 lit. b GDPR).

If you have consented to this, the legal basis for the collection of participant statistics is precisely this consent (Art. 6 Abs. 1 lit. a GDPR).

The legal basis for processing in these instances is Article 6, para. 1, lit. f GDPR (legitimate interests of the controller).

5. Recipients and categories of recipients

The registration data are collected and used within DKRZ for the sole purpose of organizing and realizing the talk, which will be held as a virtual event.

Your name and e-mail address are required for registration. The workshop will be held using the video conference software zoom by DKRZ. The slides of the presentations will be made publicly available. During the talk, questions from the audience will be collected in an editable document (hedgedoc) hosted by GWDG, which will be accessible via a public URL. After the event, aggregate data without personal reference may be used for documentation, dissemination and communication purposes. A passing on of data to third parties does not take place.

6. Storage duration

The data collected during the registration process will be stored until no later one month after the respective talk.

7. Rights of data subjects

You have the right to obtain information on the data stored about you by DKRZ, the right to demand correction in the event of incorrect data or deletion in the event of unauthorised data storage, and the right to data transfer. You also have the right to appeal to the supervisory authority.
